#### Senator Farnese Facilitates \$20,000 Grant...

FSRP was awarded a \$20,000 grant, facilitated by Senator Larry Farnese, to re-grade and re-seed Taney Field and install a drinking fountain. The ball field surface has fallen into a state of disrepair due to heavy non-stop use by many user groups. The field surface will be regraded with 200 cubic yards of topsoil and completely re-seeded sometime

during 2010. We may be able to add an irrigation system to this project if we are able to raise an additional \$12,000. The grant funds provide for a heavy-duty drinking fountain, which will be installed near the playground and tennis courts sometime during late 2009. We wish to profusely thank the Senator for his generosity.

#### Dog Owners' Survey Results...

Thanks to all who participated in the June 2009 Dog Owners' Association online survey to better understand the Schuylkill River Park Dog Community. Our findings revealed that the Park is a very welcome place for dogs. Of the people polled:

- 29% use the dog run/other areas of the park 7 days a week.
- 42% spend up to 2 hours a week at the dog run/other areas of the park.
- The park is used by the dog community all hours of the day with the highest usage in the evening. And, the dog runs/other areas are equally used on weekends as well as weekdays.
- Most of the dog community hails from Fitler Square; however, fidos and their owners congregate from all areas of the city, suburbs and New Jersey too!
- The dog community uses other amenities of the park without their dogs including the community gardens, tennis courts, playground and ball fields.

#### Survey Question Results:

- What do you like about bringing your dog to the Schuylkill River Park? Approximately, 130 people responded in the same vein....they like being able to socialize with humans and have their dogs able to socialize off leash with other dogs; the park is clean and the people are friendly.
- What do you dislike about bringing your dog to the Schuylkill River Park?
- Over 120 people answered this question in some depth. Most of the answers disclosed ... people don't watch over their dogs and people who don't have full control over their

- dogs; people who don't pick up after their dogs; the dust and general surface in the dog run; dogs off leash outside the dog run.
- What changes or improvement would you like to see? Approximately 107 people responded. There is a wide variety of responses including new dog surface that is less dusty and that doesn't hurt dog's paws; stricter enforcement of the off leash laws; no rangers; improved water fountain; more garbage cans; accountability of dog owners; water in the small dog run; more benches; jungle gym for dogs; reduction of urine smell.

On August 25 at the Schuylkill River Park at 7:00pm, the Dog Owners' Association presented a well attended conversation, 'Gastrointestinal Distress in Canines', with Dominic Dallago, VMD. Dominic a recent Dog Run member and a newbie to Center City, has offered to host ongoing 'conversations' with the dog community about various dog health concerns. Dominic graduated from the University of Pennsylvania, School of Veterinary Medicine in 2004. Since then he has been working at Veterinary Hospitals on the Main Line in Devon and Bryn Mawr and most recently at Radbill Animal Hospital. Dominic is happy to answer any pet-related questions you have and he can be seen regularly at the large dog run with his Doberman, Ty.

#### 25th and Delancey Entrance Beautification...

In early spring 2009, FSRP partnered with a neighborhood household to improve the 25th and Delancey Park Entrance. Improvements included constructing planting beds bordered by Belgium Block and an iron fence, installing an irrigation system, and placing numerous plantings. Rich and Krista Pinola, who coordinated and funded the project, held a grand opening for the entrance in mid-August. Councilman

Green, Peg Connor - President FSRP, and Mark Focht - Executive Director of Fairmount Park, spoke at the event, thanking Rich and Krista for their generosity and highlighting the importance of public private partnerships in creating and maintaining high quality Parks in Philadelphia. These improvements have set the standard for other work around the park and FSRP wishes to thank Rich and Krista.

#### Representative Babette Josephs Facilitates \$4,000 Grant...

Recently, Representative Josephs facilitated a \$4,000 grant to FSRP. These funds were used to purchase bulbs that children from the Philadelphia School planted around the park and to perform numerous improvements to the Park's tree canopy, including planting several new trees.
