### Friends of Schuylkill River Park Annual Meeting

The Friends of Schuylkill River Park will hold its annual meeting on Wednesday, June 23rd 7:30pm at the Markward Recreation Center. All *current* members are invited to attend.

### **BoConcept Arts Program**

Made possible through generous support from BoConcept, this fall the Markward Recreation Center in coordination with the Friends of Schuylkill River Park will start a visual arts program for middle to high school aged kids who express a genuine interest in exploring a particular art medium.

Tentatively, the courses will include a choice among clay hand building taught by artists from The Clay Studio, painting taught by artists from The Fairmount Arts Center, and possibly a course in sewing or knitting taught by staff from the Handwork Studio.

Registration will begin in late summer. Classes will last approximately 6-8 weeks and will be held on Saturday Mornings in the recreation center. At the end of the program, participants will be given the opportunity to celebrate their accomplishments with family and friends by holding a reception and display of their work at Bo-Concept. We are extremely excited about this opportunity and hope you know someone who will want to participate.

### **Markward Field Renovation Funding Progress**

As readers of previously newsletters are aware, the Friends of Schuylkill River Park in close coordination with the Markward Recreation Center is planning a major renovation of Markward Field that will cost approximately \$50,000. The renovation includes laser grading the field, growing new grass, and installing a sprinkler system. We have thus far secured **\$20,000 facilitated** 

by Senator Larry Farnese, \$5,000 from CSX Railroad, \$1,000 from the Dolfinger McMahon Foundation, and several hundred from individual donors. We would appreciate additional support from individuals as well as potential leads on corporate sponsors to help us reach our goal of \$50,000.

### Connector Bridge Update

The consultants for the SRDC have made their final presentation to the Art Commission and the minor revisions suggested by the Art Commission at the previous meeting were accepted. The SRDC will submit one last time to PENNDOT for their review and comment in the next month or two. It is expected that bidding on the construction work will occur this summer. Construction will begin this fall. Prior to the start of construction it is expected that the SRDC will make a final public presentation to the neighborhood. Construction is expected to take a little over a year (with a cooperative winter) with the completion of the bridge targeted for January 2012.

### Community Design Collaborative Grant

The Friends of Schuylkill River Park is the recipient of a grant from the Community Design Collaborative (\$15,000-\$20,000 in design services) to generate conceptual drawings through a community input process for improvement of Markward Courtyard (the area outside the Markward Recreation Center). The design process will begin late summer or early Fall and last for several months. Upon completion of the conceptual design, the Friends of Schuylkill River Park will need to secure funding for the development of construction drawings and then for the actual construction process.

### Mayor's Philly Cleanup and LOVE Your Park

On April 10th, the Friends of Schuylkill River Park participated in the Mayor's 3rd annual Philly Clean Up. Over 30 volunteers pruned overhanging shrubs and redistributed the gravel in the dog run, removed Belgium Block from the playground area where it was hazardous to running children. We also weeded and mulched, planted Marigolds, cleaned the tennis courts, the blacktop play areas, and the paths. Thanks to everyone for their hard work and a job well done!

On May 8, 2010, the Friends of Schuylkill River Park participated in "LOVE Your Park" a collaborative park cleanup day organized by the Pennsylvania Horticultural Society, Fairmount Park, and the Department of Recreation.

Over 35 volunteers attended, including a large team from the Internal Revenue Service arranged through Greater Philadel-

phia Cares. The hard working volunteers spread 10 cubic yards of compost and 10 cubic yards of wood mulch around our plantings, painted railings and posts around the Markward Recreation Center, weeded all the tree pits in the park, swept and cleaned the tennis courts and Markward Courtyard, and much more.

These large-scale work days are essential to keeping Schuylkill River Park well maintained. We are very appreciative to all the volunteers who turned out to help. A special thank you to Jennifer Mahar from the Pennsylvania Horticultural Society, one of the most dedicated people we know, for all of her above and beyond the call of duty efforts for us and parks around the City. We could not have done this work day without you.
